


INTRODUCTION

JOINT PRESS RELEASE

On December 5 2023 the Business Council Mongolia joined other chambers and associations in releasing a Joint Press Release aimed at creating a favorable business environment in Mongolia. The joint press release was submitted to the Parliamentary Standing Committees.













November 8, 2023

From the Joint Initiative of Chambers of Commerce and Industry to the Ministry of Economy and Development, the Ministry of Mining and Heavy Industry, and the Economic Standing Committee and Fiscal Standing Committee of Parliament:

Re: Improving the legal environment for the business and investment climate

The Joint Initiative of the Chambers of Commerce and Industry (JICCI) believes the following policy steps should be taken to improve the legal environment for the business and investment climate in Mongolia:

1. Creating an ecosystem for an enabling business and investment environment:

- · The rule of law: enforcement of the implementation of laws
- Improve the stability and transparency of the legal environment. For instance, full
 implementation of the Transparency Agreement
- · Ensuring the sanctity of contracts
- Provide investment incentives and support for investors
- Reform the judiciary and court enforcement agency to act impartially and effectively in dispute resolution

2. Develop and implement a unified policy for attracting trade and investment:

- Revision of the Investment Law in line with this policy and making it a regionally competitive law attracting investment
- To diversify the economy and reduce over-dependence on the mining industry, (a) identify
 priority areas of support and (b) define economic areas to be supported within a specific
 scope, with tax and non-tax incentives and support.

3. Carry out comprehensive tax policy reforms and create a favorable tax environment:

- Tax law should be amended to adequately reflect tax incentives, discounts, and exemptions for investors. For example:
 - o Reduction of the 20 percent withholding tax on income from the sale of shares;
 - Annul Reverse VAT;
- Urgently stop requiring the direct payment of fines, liquidated damages, or interest for recovery actions, regardless of the court finalization of tax disputes.

4. Fast and effective resolution of tax disputes

• Reform the structure of the Tax Dispute Resolution Council and make it more independent

5. Make the civil service more compact, specialized, and competent

 Develop a sustainable public service system based on citizen-centered public service culture

The JICCI believes it is necessary to include the 15 changes in total to amendments to the Investment Law and the Minerals Law, and we sent these proposals to the relevant parties in writing.

Finally, the JICCI is ready to cooperate with the Mongolian Parliament and the Government, and we propose to hold regular bilateral meetings within the framework of the Investors' Protection Council in order to exchange the necessary information.
