



Joint Policy Statements



BCM has submitted joint request to the Prime Minister of Mongolia and the Minister of Finance on issues with Tax Dispute Resolution Law on 17 January 2022 with the AmCham and the Mongolian National Chamber of Commerce and others.



BCM has submitted joint request to Government of Mongolia on issues and concerns with Corporate Income Tax Law on 13 October 2022. BCM Secretariat has submitted summary of issues and proposed solutions on newly adopted Corporate Income Tax law drafted by the Chair and Vice-Chairs of the Tax & Regulatory Working group /lead by Ms. Kh.Amarjargal, Country Director Mongolia-Rio Tinto, Mr.B.Battushig - Founding Partner of DB>S LLP and Mr.R.Khishignemekh - Senior Partner of Ernst and Young TMZ.



BCM has submitted joint request for consideration to Government of Mongolia on issues with draft Private Public Partnership (PPP) Law on 28 October 2022. The BCM Secretariat issued joint statement and amendment proposal on PPP Law draft together with UB Chamber of Commerce and others. The 10 pages of document containing issues with proposed changes in the draft PPP Law that initially prepared by UB Chamber of Commerce were submitted and addressed to the Standing Committee of Economic Affairs, to Parliament Member Minister for Mining and Heavy Industry S.Ganbaatar, Member of Parliament D.Unurbolor and Prime Minister L.Oyu-Erdene.


